Dear Sirs:

As Chairman of the Religious Education Committee, I submit the following report on the activities of our committee and the group with which they work.

The enrollment in the Sunday School has increased during the past year and at the present time stands at 245 children, the highest in three years. There has been a good average attendance. It is interesting to note that the high attendance days are those on which the children bring in their Christmas and Thanksgiving gifts.

The teaching staff has been regular in its attendance. We are continuing to experience some difficulty in getting the proper number of teachers and hope that this condition will soon be remedied. Teachers are more mature as a group than they have been in the past year.

The church facilities have been used during the past year for the activities of the Girl and Boy Scouts, The Inter-college Club, and the Pilgrim Players. In fact, most every evening there is a meeting of some kind held in the church.

Last year we were instrumental in organizing the University of Life in conjunction with two other churches in our community. The present season finds that this activity is not creating as much interest as it has in the past. It may be possible that some reorganization of this will be necessary.

The Children's Choir has been well attended. The membership at the present time stands at approximately forty-five. We have been able to have at least thirty-five in church each Saturday morning for rehearsals.

An effort has been made to build up a closer cooperation between the teachers and the Religious Education Committee. Wherever possible these two groups are called together.

During the past few months the Religious Education Committee

Report of the Chairman of the Board of Trustees of Pilgrim Congregational Church.

It is customary for the presiding officer of an organization to make a report at the beginning of a new year on the "state of the union". I will leave this to those officers of the church and associated organizations that follow and, as Chairman of the Board of Trustees, merely mention a few of the matters that particularly are in their charge.

The church is in better financial condition than last year although we still need the thoughtful financial co-operation of every family in the congregation, due to the loss of some of our substantial supporters. The church would have maintained its old record of always coming to the annual meeting with all its current bills paid if either one of two major payments could have been avoided. An additional payment of \$560.00 was made on the mortgage in addition to the regular one of \$500.00. A very necessary expenditure of about \$500.00 was made on the Manse of weatherstripping and insulation to reduce an excessive fuel cost. The pastor reports a marked improvement since the work was done. The concrete steps at the entrance of the church have been repaired and a leak in roof over the organ fixed. We came to the end of the year with about \$500.00 in unpaid bills, which is about half of last year's closing.

The every-member-canvass was exceptional in the co-operation of the members of the congregation. An increased budget was raised in record time. To Mr. Carlson and his associates, Mr. Hegerdt and Mr. Voss, credit is due for the preliminary venison dinner generously attended. "Believe-it-or-not" it was a dandy and that without the assistance of the ladies.

Another innovation was the "Victory" dinner on the Wednesday following the canvass when a report was made. It was a family affair, arranged by the ladies in the way for which they are famous. The dinner was a "dead-line hour" for the

team captains to report final results and possibly accounted for the early conclusion of this part of the work.

For 1937 the adjusted budget was \$17,987.00.

At the "Victory" dinner this year the treasurer reported pledges of \$17,038.20 to which will be added the loose collections and the Easter offering, totaling about \$18,838.00. If the ladies add their usual generous support, the budget will not miss the goal by a great deal.

I trust that the revision of the budget will not eliminate suggested repairs to the church building. Re-decorating is needed and some adjustments in the heating plant are advisable.

As the denomination is committed to the "Debt of Honor", I recommend the appointment of a special representative group to consider Pilgrim's share.

Due to the co-operation of the pastor, the church secretary, Mrs. Manley, the treasurer, Mr. Stilliman, Mr. Buck of the Buildings and Grounds Committee, and others having to do with the business of the church, the duties of the trustees have not been exacting.

As chairman of the board, I wish to convey the thanks to these people and all other officers, committees and members whose efforts are responsible for what I consider a very successful year.

REPORT OF BOARD OF DEACONS
Annual Meeting, Jan., 18th, 1939.

During the past year the monthly, and latterly the semi-monthly meetings of the Board of Deacons of Pilgrim Church have been ~~xxxxxxed~~ well attended, with most of the Fifteen deacons present at each meeting.

Under the leadership of the minister, we believe that some of the enthusiasm and discussions of those meetings have been reflected in the activities of the church. The suggestion in the fall by the minister that Mr. Donald Adams of Boston be invited to visit us and address the men of the church and congregation upon the subject of a Layman's Fellowship, was heartily seconded by the Board of Deacons, with the result that Mr. Adams was present and addressed a large group of men at a dinner in the church in November. The subject especially emphasized by him was the desireability that in every church a specific job should be found for everybody in the church.

^{Mr. McQueen} ~~The minister~~ has announced to the deacons that he has a list of one hundred men in the church who are not assigned to any specific task. A committee has been appointed with Mr. Reynolds as chairman to undertake the assignment of jobs to these One hundred men. With the full accomplishment of this undertaking, it would be difficult to measure the magnitude of its contribution to the aims of this church.

During the year three collections have been taken for the deacon's fund. The congregation has responded with characteristic generosity. Such contributions have amounted to \$129.96, which together with \$55.00 special contributions by individuals, have enabled the treasurer of the fund to maintain a reserve at all times for emergency calls.

We believe that under the leadership of Mr. McQueen, there has never been a year in the history of Pilgrim church that has been richer in real values than the past year. These values are reflected in the morning services, with a high average of attendance; in the Sunday School with its sustained membership and efficient teachers; in the choir and church music, unsur-

passed in the city, and in the University of Life, the Boy Scouts and Girl Scouts which, together with the other organizations of the church, give it the appearance of a busy center at all times of the week.

While we may thus justly congratulate ourselves upon the splendid leadership of our church; upon its organizations; upon our music and upon our complete equipment for the comfort of our members and congregation, are we not, perhaps, in danger of forgetting the whole ~~purpose~~ ^{responsibility} of Pilgrim church, as defined in its constitution, from which I quote?

"The purpose of this church is to further the understanding of the principles of Jesus and their application to character and conduct in the life of its members and throughout the world."

There it is in therecord. Pilgrim Church's privileges, opportunities, and obligations are not for ourselves alone.

"Lord God of hosts, be with us yet, lest we forget, lest we forget."

In 1887 a new church was constructed at the site of the present Boys' Y building at Lake Avenue and Second Street.

The present building was dedicated on Christmas Sunday 1917.
