

REPORT OF THE MINISTER

From beginning to end 1979 was an eventful year. Much time and energy were spent by many of us during the opening months in getting ready for the first large denominational gathering held at Pilgrim Church for a long time — the annual meeting of the Eastern Minnesota Association of the United Church of Christ. The retirement of Dorothy Belt as secretary and office manager and her replacement by Charlotte Lee brought both sadness and celebration and major administrative adjustments.

In many respects, however, the first three fourths of the year were spent gearing up for the last quarter. In my own mind these fall months took on the significance of a "great leap forward" when we would conduct major experiments in enriching the program of the church, reaching out to others and in determining whether my own leadership might still be useful. Every department of the church was involved in active planning without letup, not only in the winter and spring, but through the summer as well, looking toward the fall program.

The fruit of this planning resulted in such developments as these:

*Inauguration of the "Living the Word" curriculum by the church school.

*A new Sunday morning schedule which provided for adult and youth programs, extended church school class-time and involvement of the entire church in corporate worship.

*A revitalized "Pilgrim Rediscovery Month" in September.

*Installation and dedication of the Roberts Window,

*The start on a trial basis of a church radio program.

*Formation of a task force to search for ways in which the church might serve the needs of older people, possibly by helping to sponsor a continuum of care facility.

*The joining of the Committee on Stewardship and Mission with the Committee on Social Concerns of Peace Church to sponsor resettlement of a refugee family from Southeast Asia.

*Extensive building repairs and comprehensive assessment of building use and needs by the Board of Trustees.

(*The minister's ordination anniversary happened too, although it was not part of the game plan.)

In all cases they were developed in response to concerns raised by individual church members either at the colony meetings in the fall of 1978 or in the ensuing months. Some of the results have been very heartening. I do not believe that anyone expected so large a weekly response to our adult discussion program. The youth program also has come to life under the very able and dedicated leadership of Clyde and Julie Johnson and of discussion leader, Judy Casserberg. The children's work continues to develop creative new wrinkles as evidenced by Kathy Hanson's singing sessions.

There have been disappointments. The usual crop of new residents did not appear in September. Never in recent history have so few new members been received. Some plans moved more slowly than we might have wished, partly because I was not able to keep on top of all church affairs as completely as I desired. On the other hand, several new families began to

join us in worship toward the end of the year, and some important projects move forward.

Through all of this your Moderator, Joan Morrison, has stood like the house built on the rock. Under the leadership of Lucy Brenning the Board of Christian education has functioned more effectively than at any time within my memory. Huck Andresen led the Trustees through a year of hard financial decisions and Joe Leek gave his inimitable leadership to our stewardship campaign. Many other individuals have stepped forward to take charge of a variety of chores. A favorite sermon text is the one from Ezekiel about God's fruitless search for a man to stand in the gap. How much more blessed we are that we have someone like Betsy Brownell who leaps head first into every gap that opens. Mentioning names is risky because many get left out, but I cannot close this review without expressing my gratitude to Bob Reichert, chair of the Diaconate, for his abiding support and to Lynn Frigaard for looking after me and the church at a time of year when I deceived her into believing that nothing would happen.

As we look to the future it is clear that we cannot impose much longer on the patience of Ray Baker and the Music Committee respecting their proposals for the organ. It is clear too that we should return Bill Hedenberg's scaffolding and provide a permanent protective shelter for the back entrance. These and other building needs may require the raising of special funds this year.

It is also clear that the church needs the assistance of a vigorous, imaginative and professionally trained young person to share in the ministry of the church and that such assistance should be secured with all possible dispatch.

For most of the summer the church will be privileged to have as its exchange minister, the Reverend John Young of Argyle Street United Reformed Church (formerly Argyle Street Congregational) in Bath, England. Having served recently as national Moderator of the United Reformed Church, a union of Congregationalists and Presbyterians, Mr. Young is one of the outstanding church leaders and preachers in his country. I hope that our congregation will do its best to extend him welcome and to profit from the gifts he will bring.

Therefore, the coming year also promises to be eventful. Over the past year I have found myself at times growing somewhat shaky due to a variety of pressures. You have stood with me. Perhaps in this mid-winter we may grow so ecumenical as to quote a romantic atheist, "if winter comes, can spring be far behind?"

STEWARD'S REPORT

This year an effort was made to draw every member to church on Loyalty Sunday, both to commit their pledge and themselves to Pilgrim. This was reasonably successful. By year's end, about 90% of all anticipated pledges were in and there was an overall increase of about 5% from those making commitments.

A total increase of 13% is needed and a secondary campaign might be essential to insure a satisfactory equilibrium.

In the future, I suggest that the job of Steward should be more defined with the chairperson serving one year with a replacement being on-board to with the Steward and learn about the position. I also feel that an everymember canvass needs exposure about every three years to revitalize the integrity of our giving.

1979 was a busy year at Pilgrim. We celebrated Dorothy Belt's many years of service, Dr. Shepard's 25 years in the ministry, and the installation of the Roberts window. We hosted the annual meeting of the Eastern Association. New committees were set up to study the covenant and to begin looking at the possibility of a continuum of care facility. The Diaconate was asked to develop a policy for sabbatical leaves. The church school began using a new curriculum and the Board of Christian Education developed and implemented an extended Sunday morning program. A group of volunteers brightened Fellowship Hall with a new paint job. Elsie Jean Austin resigned as the Director of Christian Education effective December 31, 1979, following nine and a half years of service to Pilgrim Church. A committee is now in the process of looking at our future staff needs. It should be noted that most of these activities were in addition to the "usual" business of the various boards and committees.

All of these activities involved uncountable hours of staff and congregation time. Last January the clerk reported that we had an active resident membership of 509. Of that number approximately 140 people (37%) were involved in some way in the work of the church. Involvement included such things as arranging and delivering flowers, singing in the choir and committee and board work. I need to state that this is not a particularly precise figure but rather the result of some elementary mathematics on my part. On the one hand I was impressed by the figure but on the other hand it was sobering to note that this is less than half of our active membership.

I will work to provide more opportunities for participation and would encourage the boards to do the same. It will also take some assertiveness on your part, however, to let us know if you would like to become more involved. I'm sure the nominating committee would appreciate hearing from you or you could let the church staff or myself know. I believe we have just begun to tap the potential we have in this congregation.

As I reviewed annual reports dating back to 1971 to gain a better perspective of where we are at today, two items appeared in several reports. One was a reference to being in a "transition period" and the other was concern over our financial situation. It is not distressing to me that these two concerns apply as much today as they did in the past. With sound management and committee members we have done a good job of dealing with our financial problems and I am optimistic we will continue to do so in the future. A transition period involves change and frequently conflict. In any transition period there is a time to openly express differences of opinion and a time to pull together. The end result can be positive growth as has been the case in the past. I am optimistic that once again there will be positive growth.

Looking ahead to the balance of 1980 it is clear it will be another busy year and we will need to work together to meet the challenges we face. I am hopeful the number of involved members will increase, we will continue to develop a program that will attract new members to Pilgrim, and we will remain a strong and united congregation.

A sincere thank you to each of you for giving me the opportunity to learn and grow personally this past year.

The impressive and most meaningful Easter and Christmas services along with the Confirmation, Church School, and the September "Family" theme worship services indicate a great feeling of fellowship within the Church.

November 11th was commitment Sunday with greater meaning than many of us realize.

The dedication of the Roberts Memorial Window on October 14th was the culmination of the dedicated, appointed task force. Henry Roberts, Arthur Roberts son, Odell Prather, designer of the window, and Charles Andresen Roberts son, United Prather, designer of the window is in keeping with Mr. Roberts spoke at the ceremony. Judging from the enthusiastic reports given by Julie Smith and Marge Anderson concerning the Cincinnati Conference on Women for Leadership and the ensuing lively discussions, we feel that more women are becoming involved in leadership.

In looking for a new secretary, we had the good fortune of engaging Charlotte Lee for that position. Her varied and successful past secretarial positions give us great confidence that our Church office is in good hands.

A big thank you to the Wisconsin Conference of U.C.C. for its grant of \$2,000 to the Twin Ports Ministry to Seafarers.

After much work by the Special Task Force, it came up with an extended Sunday worship service. The new format includes children worshiping with their parents through the time of offering, at which time they and their teachers leave for their regular classes. Following the service there are adult and senior high discussion groups. This new format was implemented September 9th with 10:00 A.M. as the time of service.

On November 18th at 9:00 A.M., the first radio program, "The Living of These Days" was broadcast (95 on the FM dial - 1300 on AM) Included was music by the choir and a sermon by Dr. Shepard.

These innovations along with the Church's various commitments to local needs and needs beyond the community prove Pilgrim Church is indeed a viable institution.

REPORT OF THE BOARD OF TRUSTEES

The trustees are pleased to report that the church has maintained a stable financial position during 1979. Special thanks go to Dr. Joseph Leek who again chaired the Building on Commitment solicitation of our church members.

The sum of \$24,375.00 was authorized to purchase and install the Roberts Memorial Window, which window was dedicated this past fall.

A new mimeograph machine was purchased for the office and funds approved for the acquisition of dictation equipment.

The trustees authorized the expenditure to pay the air travel expenses of Reverend John Young, interim minister during Dr. Shepard's sabbatical, plus the sum of \$100. per week support income for the months Mr. Young spends at Pilgrim Church.

The trustees have established a committee to review the use of the church facilities for non-church activities and to establish uniform rental fees.

During the past year numerous repairs have been made in the church, and the building committee is preparing a priority list of building improvements including the installation of a permanent cover over the alley sidewalk. The trustees are also developing an energy conservation policy for the church building which has included additional insulation and the installation of a time clock control on the heating plant.

The trustees have committed themselves to pursue funds for repairing and refurbishing the church organ in 1980.

1979 saw the retirement of Dorothy Belt as church secretary and the hiring of Charlotte Lee as her replacement.

My thanks for the support of the trustees, our treasurer Jesse Bradley, and Doctor Shepard during the past year.

Resolution of the Board of Trustees

Be it resolved that Elsie Jean Austin receive as severance pay from Pilgrim Congregational Church, an amount equal to four months of her 1979 salary plus one year's health coverage. Said total amount to be paid in four equal monthly installments payable on the 1st day of February, March, April and May 1980.

The Diaconate fulfills its responsibilities of assisting the minister regular committee responsibilities include: assisting the minister with the worshipers, assisting at the communion service, providing flowers for church providing transportation for those who need assistance, coordinating colony liturgists and arranging for pulpit supply. Representatives of the Diaconate dential Committee and the Staff Needs Committee.

A number of important events occurred at the Church during the past year. Among special activities in which the Diaconate participated were the decision to expand the Sunday morning program, inauguration of a Sunday morning radio program, the Third Annual "Pilgrim Rediscovery" events in September and formation of a new church Hospitality Committee.

The Diaconate discussed staff needs of the church following Dr. Shepard's letter to the congregation. On behalf of the Diaconate, a resolution was presented to a congregation meeting that resulted in formation of a staff needs committee that will report on its findings at the annual meeting.

The sabbatical for Dr. Shepard that the Diaconate has been planning for the past two years has evolved into a pulpit exchange with the Reverend J. E. Young of the Argyle United Reformed Church in Bath, England. Tentative plans are for the pulpit exchange to occur for approximately a three to four month period during the summer of 1980.

In response to a charge at the last annual meeting to develop a sabbatical leave policy statement, the Diaconate unanimously approved the following statement for presentation to the congregation at the 1980 annual meeting:

The policy of this church is to support a sabbatical program for the church's professional staff. Terms of the sabbatical (duration, financial support, period of service required before eligibility, subsequent service requirements) shall be discussed and agreed upon at the time of the call.

Board members conscientiously accept and carry out the responsibilities of the Diaconate. The committee structure works well and will continue to serve as the means for performing regular activities. The Diaconate expects to continue the fall Pilgrim Rediscovery as an annual event and to evaluate the radio program with the hope of continuing the program.

A major event during the year will be the pulpit exchange with Mr. Young. The Diaconate looks forward to active involvement by all members of the Church during Mr. and Mrs. Young's time with Pilgrim this summer.

All members of the Diaconate provided valuable service, but the Board wishes to express special appreciation to the members who are completing their service: Betsy Brownell who served on the membership and baptism, visitation, and stewardship and mission committees and who is active in formation of the new church hospitality committee, and Wilbur Fox who served on the lookout and transportation committees and performed an excellent job of distributing Sunday flowers and arranging transportation for those who need it to attend church services. Two persons who are completing a one year term and who have been active members of the Diaconate are Clifford Grindy and Thomas Exickson.

The past year has been a challenging one for the Board of Christian Education. Christian education work has taken new directions in the church school, in youth work, and in adult education.

In the spring, after careful study, an exciting new church school curriculum "Living the Word" was selected. "Living the Word" is biblically based with emphasis on application to everyday living situations; its theology is similar to that of the old curriculum but methods and approaches have been refreshingly updated. Following a teacher training workshop led by the Rev. Margaret Morris, the new curriculum was put into use in September by a dedicated staff of 15 teachers. Group music sessions have also become a regular part of the church school.

Both the youth program and adult education were significantly altered with the implementation in September of the new Sunday morning schedule. A high school class, including the Confirmation class, now meets after worship one Sunday a month and several times a month at other times for study, fellowship, and fund-raising.

A great deal of the Board's time, energy, and enthusiasm have been invested in the development of an ongoing adult education program. The theme this year has been "The Christian Perspective on the Family--Immediate, Church, Community, National, and International." The Board feels that the format of three Sundays per topic -- one with a speaker or film, one with a panel discussion, and one with small group discussion is providing an excellent opportunity for growth among Pilgrim members -- for the exploration of our Christian values and for fellowship through the exchange of ideas.

The Board feels very strongly that Christian education -- child, youth, and adult -- is fundamental to the life of the Church. In an otherwise secular society largely indifferent or hostile to Christian values, it is of primary importance that the children of the Church become acquainted with the origins of the Christian faith and the application of its beliefs to the problems of life. It is also important that we have a youth and an adult education program. Our members should be involved in Christian study and be encouraged to participate in the exchange of ideas and experiences which will improve the quality of their lives.

The Board of Christian Education hopes to continue to strengthen Pilgrim Church's Christian education program and welcomes any suggestions of ways to do this. The Board sincerely thanks the church school teachers and those who have provided leadership for the youth and adult programs. For the Christian education program to remain vital, willing participation by many members is essential. The Board urges each member to consider whether he or she might be willing to teach in the church school or to provide leadership for the youth or adult program.

The Board sincerely regrets the loss of the leadership and support of Elsie Jean Austin and wishes to express gratitude and appreciation to her for her faithful and effective service to this church.

It is the hope of the Board that a new staff person hired in addition to the minister should carry as his or her primary responsibility the Christian education program.

We asked for and received thorough studies of the instrument from two specialists: Ronald Gauger, PhD, organist at U.M.D., and Kim Kasling, PhD, organist at St. John's Abbey, Collegeville. Following their recommendations we asked for an assessment of the mechanical condition of the organ from organ builder, Richard Lurth, of Mankato, Minnesota. (Recommendations from organ builder, Clarence Gould, of St. Paul, are already in our files.) Mr. Lurth's proposal was accepted by the committee for the following reasons:

It is less costly than Mr. Gould's.

It is based on preserving the instrument as it now stands.

It offers a more reliable standard of upkeep.

The committee presented Mr. Lurth's proposal to a meeting of the Board of Trustees in July.

Soprano soloist, Jeanette Myers, and tenor soloist, John Olund, resigned from the choir during the summer --- both moving from Duluth. We feel very fortunate to have found excellent replacements: Lorraine Langer and Bruce Johnson, both students at U.M.D.

Committee member, Kathie Hanson, has initiated a singing time for the church school young people. Response to her leadership has been enthusiastic. It is also thanks to Kathie that "Notes From A-Loft" were inserted in the church programs during the summer, encouraging everyone to consider choir membership.

COMMITTEE ON STEWARDSHIP AND MISSION

Committee members in 1979 were Judy Casserberg, Ellen Harkey, Gertrude Jacobson, Ruth Lewis, Irv Parson, and Margo Zentner.

Your committee continued its responsibility as your servants in the distribution of your compassionate outreach. The primary functions have been education of the congregation and disbursement of funds.

Reports have been given through "Moments of Concern" materials in our church services and bulletins. Programs, as attended in the adult Sunday discussion meetings and the "Safari in Africa" report by Reverend and Mrs. Dickinson about overseas mission, where they had served in Africa, all have helped recognition of mission.

Pilgrim Church's mission began at home. Monies have been used to serve local needs through CHUM, Arrowhead Council of Churches, the United Campus Ministry, Northland College.

The chief funding effort has been expressed in the budgeted item listed as Our Christian World Mission (OCWM). Special offerings have been dedicated: One Great Hour of Sharing (OGHS); Neighbors-in-Need (NIN); Thanksgiving, for use in our refugee project; and Christmas Fund for Veterans of the Cross.

A suggestion was made to the committee about a need for a church sponsored facility providing a continuum of care for the elderly. Apartment living with available nursing and infirmary care needs would be indicated. Such a major project might well involve one or two other churches. The Church Council acted to form an ad hoc committee to investigate this matter.

The most innovative project activated this year was the sponsorship of a refugee family to be brought to our community. Peace Church has joined with Pilgrim in this action. An ad hoc committee has comprised members of each church and is about ready to apply for such a family. Application will be made through the Church World Service (CWS) and its Minnesota regional office in Austin. Each congregation has given approval to this program and through special offerings at Peace Church and the dedication of Pilgrim's Thanksgiving gifts, adequate funds have been made available for this joint activity. Members of each congregation will be asked to serve as individuals and committee members to serve in some of the involved tasks.

The Women's Fellowship of Pilgrim Congregational Church sought to plan monthly meetings with special appeal to the women of the church. All Pilgrim women are welcome at all monthly luncheon meetings held at the church as well as at the evening group meetings held in members' homes.

February - A review of "Letters From the Field" by Margaret Mead was given by Marjorie Dinham.

March - We met at the Twin Ports Ministry to Seafarers for a tour and talk by Mr. Radtke and Ms. Almquist.

April - Rev. and Mrs. Dickinson presented a slide talk on missions in Ghana.

May - Margaret Morris spoke on women in the ministry.

June - Martha Wallace read selections from Marjorie Wilkinson's book, "A Faith for All Seasons".

September - The Fellowship met at Viette Rouses's home and planned activities for the remainder of the year.

October - A retreat to discuss the women's issues brought up at a conference sponsored by the U.C.C. was planned, but was cancelled due to lack of interest. At the regular meeting, we worked on items for the bazaar.

November - We held our bazaar.

December - The Ray Baker Singers provided some Christmas music. Gertrude Jacobson read an original Christmas story.

January - Genevieve Plumb showed slides of their trip to Portugal.

Other Activities:

The Fellowship organized the reception celebrating Dr. Shepard's 25th year in the ministry.

The Fellowship hosted the Church Women United meeting on December 7. Close to 100 people attended.

Several boxes of clothes were sent to Delmo.

A special thanks to Dr. and Mrs. Bray for their gift of furniture for the Ladies Lounge.

Thanks to all who gave of their talents, time, and money to the bazaar. It was a success both financially and in terms of fellowship among the women -- preparing the items, and during the event itself. It is this type of event which brings the women of the church closer together.

REPORT OF THE AD HOC COMMITTEE TO STUDY THE COVENANT

"Change the Covenant?" "Whatever for?" "What is good enough for the Founders of this church is surely good enough for me!" "All this bickering about language is silly; it doesn't change anything anyway." "Everyone knows that 'man' is used as a generic term in the English language!"

Reactions such as these are common. Change for the sake of change is foolish. There was a committee last year which carefully considered several alternatives, and concluded that they would recommend "no change." But at last year's meeting, the motion to accept that committee's report was tabled. The issue was of concern to enough people that it remained alive. The moderator was asked to have yet another committee examine the wording of the Covenant.

With all this in the background we met. Initially various opinions were expressed about whether such a change was desirable...and especially about the significance of such change. Regardless of individual opinions about whether such changes "really matter," (some committee members seemed to feel the arguments to be trivial) we did agree that equality is the theological intent of the Covenant. Even while recognizing that many feel such concerns to be nit-picking, we also agreed that persons who had become sensitive to "exclusionary language" would be offended, and would feel

excluded by the present wording. We did not pretend to resolve the issue of whether or not the use of male word forms influences attitudes. We did of whether fact that there have, indeed, been changes in the type of discuss the discussion in the church which is considered appropriate for women.

We concluded that we would recommend a change in the wording if we could discover phrases which a) would not destroy the flow of the language, and b) which might enhance, but certainly not diminish the theological and by with the struggled with The Interpreter's Bible, various dictionaries, and some other documents which were brought to our attention.

The committee recommends that the Covenant be amended to read as follows: COVENANT

We are united in striving to know the will of God as taught in the Holy Scriptures, and in our purpose to walk in the ways of the Lord made known to us. We therefore join and covenant with each other to worship, work and serve together as loyal disciples of Jesus, to live within the human community a life of righteousness and neighborly love, and to do all within our power to promote the reign of God's will in all human relations.

We have suggested substituting the term "neighborly" for "brotherly." In the Great Commandment we are admonished to love our neighbors as ourselves. For the phrase "among our fellow men," we have substituted "within the human community." With this change we emphasize the interdependence of all humans - an obvious concern on today's world. The special relationships with the Christian community - the Koinonia - is also held before us as a goal of life within the Covenant.
